Participation Requirements

Registration for the Helper Camp has no age restrictions. Both young participants and adult helpers will be supervised equally.

The participants in the Helper Camp will be doing practical work. It is therefore necessary that each participating helper has two dogs with them to work with.

Participants who are not yet of legal age must be accompanied by a **parent or guardian** for the duration of the camp (Section 1, Paragraph 1, No. 4 of the Youth Protection Act).

On Saturday evening we will go out to eat together with all the instructors and participants. We are currently looking for a suitable option and will make sure to find the most reasonable prices for the meals. In order to be able to reserve for the number of people, we need to know the number of people participating. You can use the online form to let us know if you would like to join (it is recommended 3).

On Saturday, July 19th, all participants check in at the camp from 8 a.m. Dogs brought along must have liability insurance and a valid vaccination certificate!

IMPORTANT:

It can get hot in July: please make sure that your dog is kept in a shaded area with sufficient ventilation and that water is available at all times. We will check on site and will have to expel any participant who does not comply with this. Thank you!
